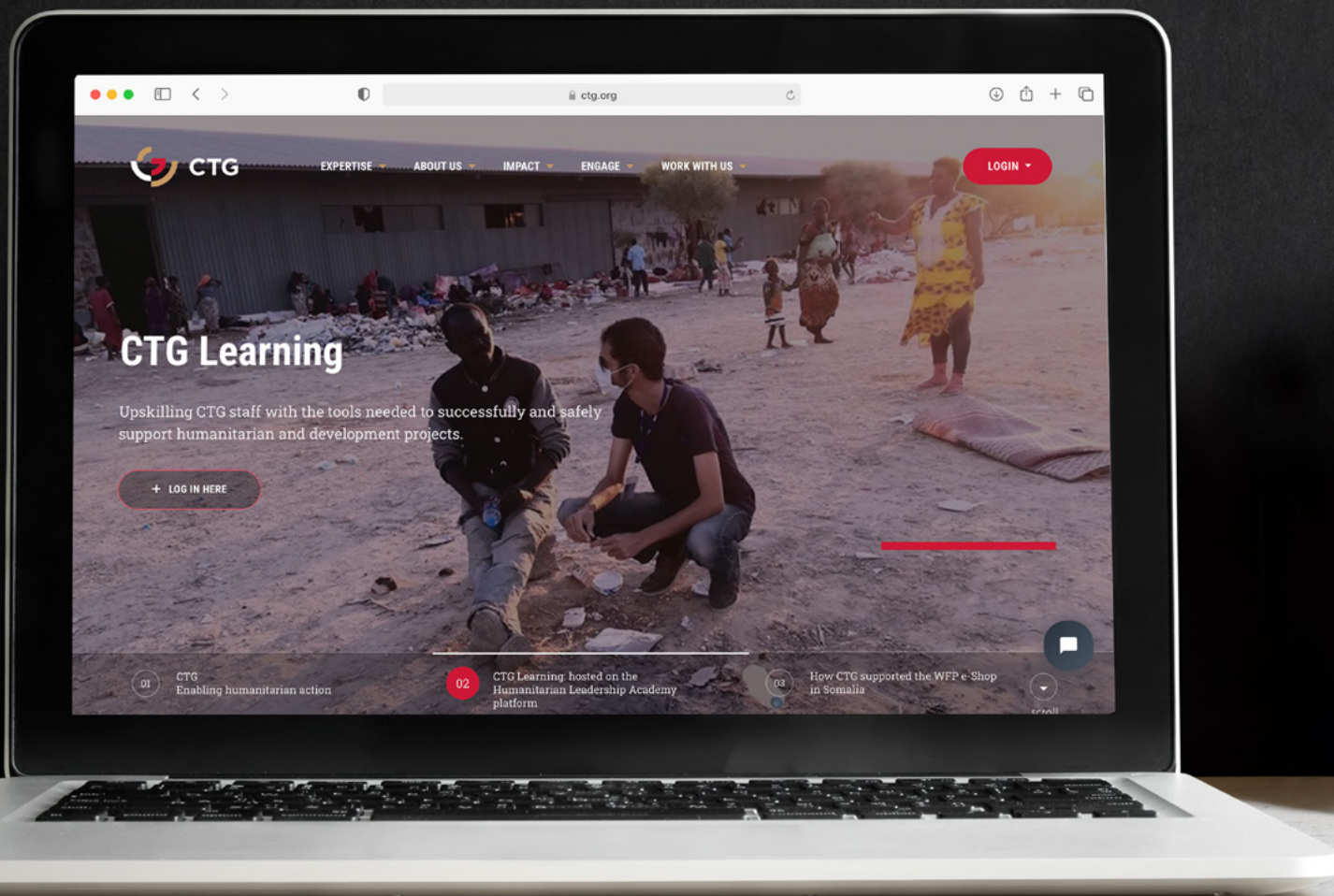

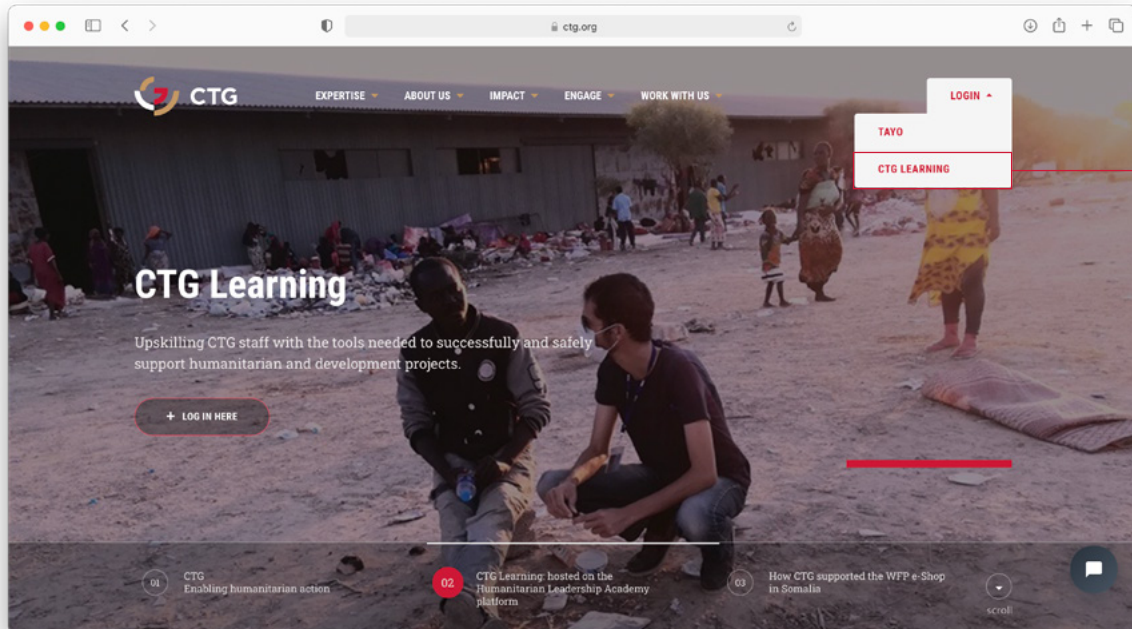

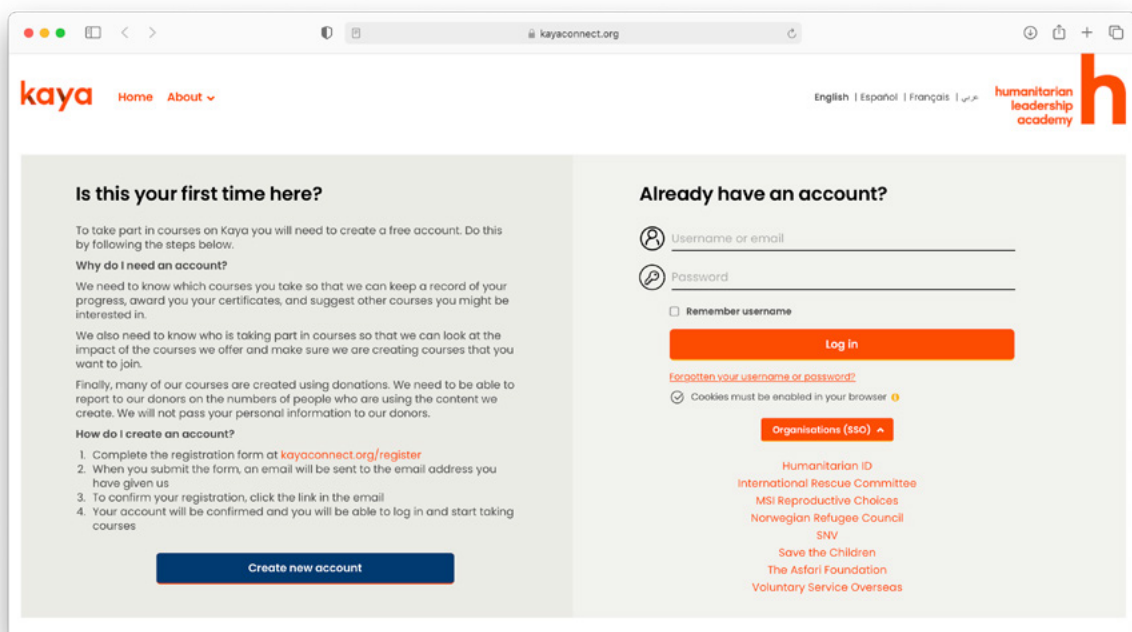
STEP 1: Visit **www.ctg.org** and head to the login tab on the right hand side of the page. Click on CTG Learning on the drop down.

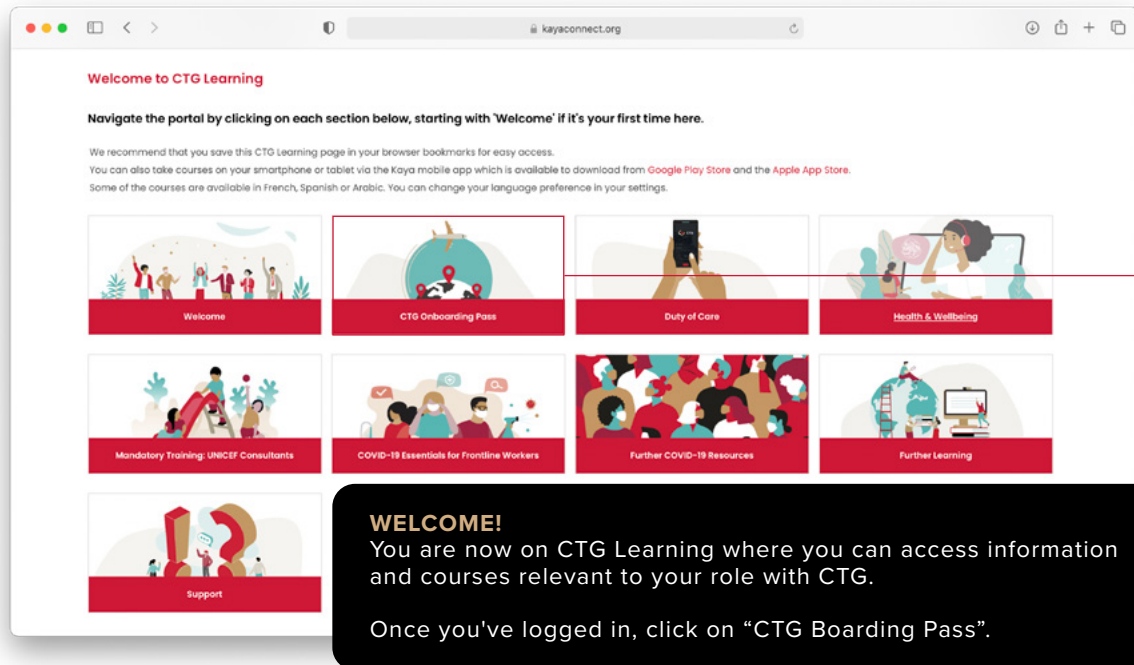
STEP 2: Login or Create an Account on Kaya. This will then take you to the CTG Learning home page.



CTG ONBOARDING PASS



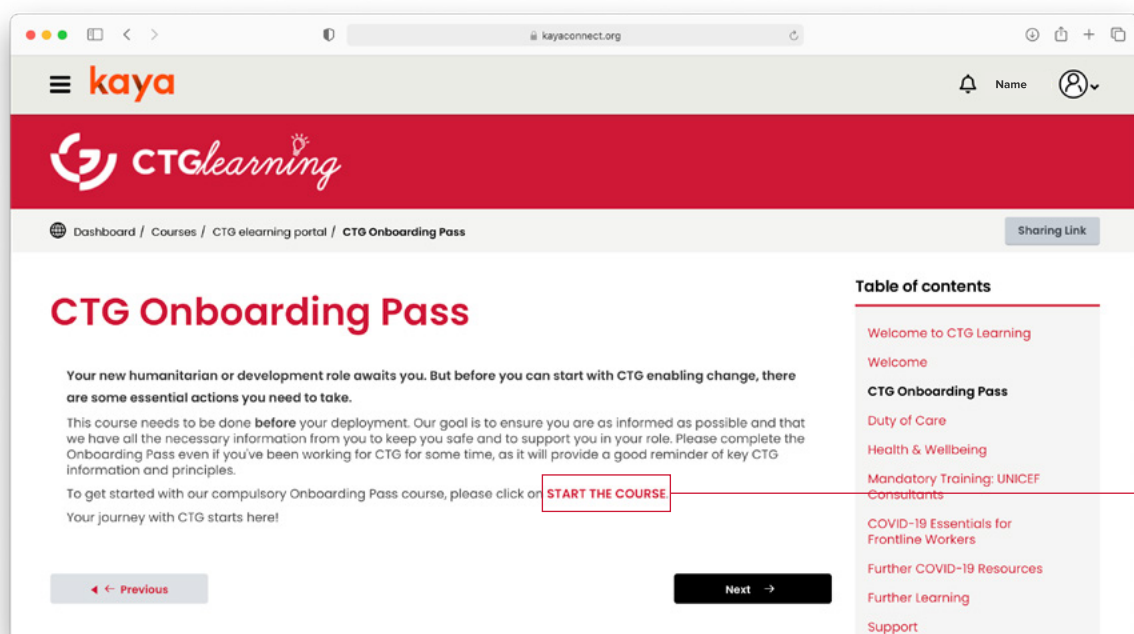
STEP 3: Once on the CTG Learning page, head to the CTG Onboarding Pass. ←

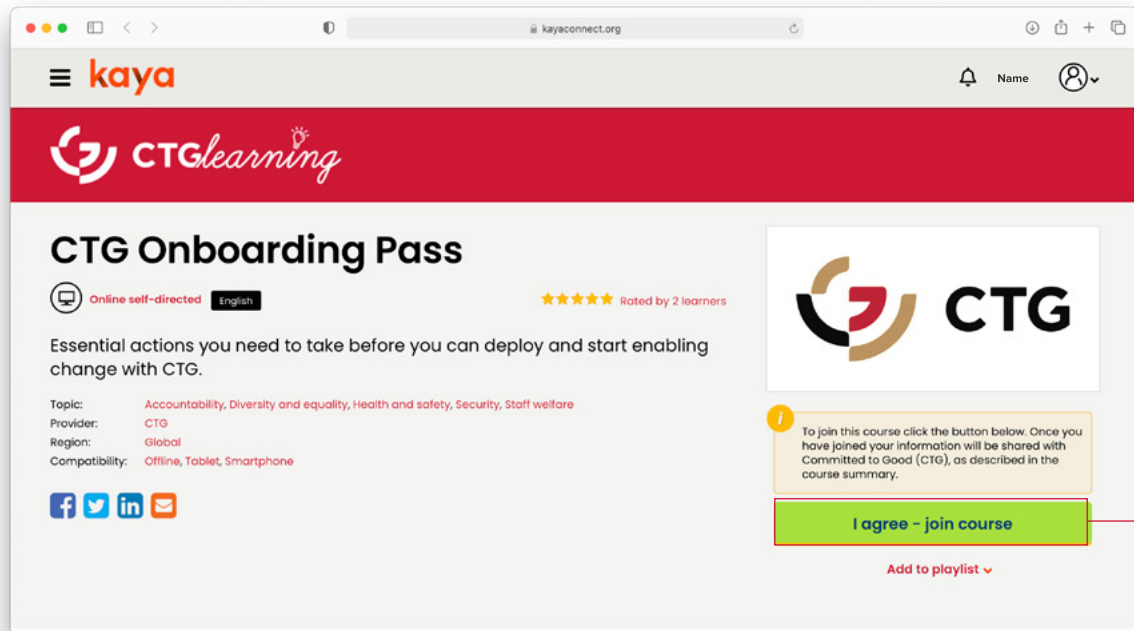
STEP 4: Accessing the CTG Onboarding Pass: Click on START THE COURSE. ←

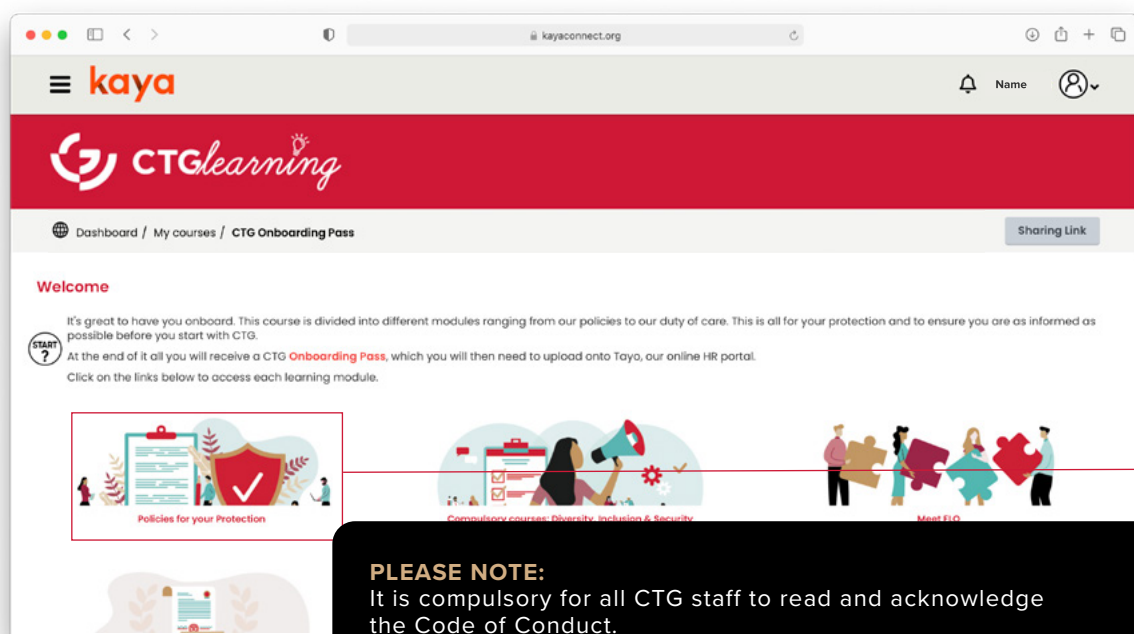
STEP 5: Click on I agree - join course. ←
